Date, Time, Reporting Officer: 04/04/2022 01:23 am CPL R.D. Lowery

Description of the Incident:

I, Cpl R.D. Lowery, was patrolling east on Strasburg Road in the area of A.S. Rhodes Elementary School on 04/03/2022. Dispatch advised over the radio that Warren County Sheriff's Office had a pursuit on 522 heading south in the area of Reliance Road and speeds of 40 miles an hour. I advised dispatch that I would be in route. I asked dispatch if WCSO needed stops sticks and was informed that they did request stop sticks.

I activated my emergency equipment and proceeded north on 522 from Riverton. Dispatch advised that the vehicle had turned into Royal Farms off 522. As I approached the intersection of Riverton Commons and 522, I observed the vehicle continue to 7 Eleven. I made the left turn and proceeded to the 7 Eleven.

As I entered the 7 Eleven parking lot, I observed a dark colored Ford F150 parked on the east side of Seven Eleven. There were numerous Warren County Sheriff's Office vehicles behind the Ford F150. I arrived on scene and I observed a male open the driver side door of the Ford F150 and exit the vehicle with his arms down by his side. The male appeared elderly and confused. The sirens were still activated on some of the WCSO vehicles. The male walked back towards the deputy while holding his keys and then turned around and walked towards the back of his truck and turned back towards the Deputy.

Another Deputy ran behind the male and placed his arms behind his back and jerked the male around towards the Ford F150. The Deputy slammed the male into the camper top face first. I observed the male spit something out on the pavement just below his body. Another Deputy came from the side of the male and grabbed the male while the other Deputy had his hands behind his back. The male was pushed over but his legs had caught the hitch on the back of the truck. Two deputies and the male were on the ground at this point.

There were numerous deputies on scene and it appeared they had the male in custody. I cleared the scene and notified Sgt King of the incident. I learned later via radio traffic that the male had suffered a laceration to his head and was first transported to Warren Memorial Hospital and later taken via ambulance to Winchester Medical Center.
