## WCSO at a Glance



- The County of Warren, Virginia consists of 214 square miles of beautiful mountains, valleys and rivers with approximately 41,440 residents. The county seat is the Town of Front Royal (VA) which has 15,263 residents ([U.S. Census Quickfacts](#) 2022) and is also serviced by its own police department.
- Our diverse rural county has 17.7% of the population being over 65 years of age, and 7.1% are military veterans. There are ten (10) public schools, one large private university, and three private preparatory academy providing education to residents.
- As of January 01, 2023, the WCSO budgeted for 67 sworn deputies (full-time), with 40 sworn deputies responsible for patrol functions, including 11 School Resource Officers. The Sheriff's Office continues to attract and retain valued employees despite nationwide staffing shortages in law enforcement.
- The WCSO had ten full and part time civilian employees, and 14 full and parttime communications officers to start the year.
- The WCSO consists of the following Divisions; Administration, Patrol Division consisting of Operations, Animal Control (ACO), School Resource Officers (SRO), and Canine, Civil Processing, Criminal Investigations Division, Sheriff's Investigations Unit (S.I.U), Emergency Communications Center (Dispatch E911), and the Community Policing Unit (CPU).
- The Sheriff's Office total operating budget consists of five sub-divisions (Animal Control, Court Services, E-911 System, School Resources, and Sheriff's Office) which can be located on the [Warren County Government website](#). Sheriff Butler has continued his trend of providing excellence in community services while coming in under budget.

## WCSO 2023 Successes

The Warren County Sheriff's Office continued its success at receiving state grants to support operational efforts in key areas, such as provisions for procuring much needed traffic safety equipment, tire deflation devices, recruiting materials and displays, and the continuation of the School Resource Officer grant program which pays the salary of one SRO.

On the 15th of June 2023, the Warren County Sheriff's Office achieved official certification from the Virginia Department of Criminal Justice Services, thereby earning the esteemed designation as the 13th law enforcement agency to be recognized under the Certified Crime Prevention Community (CCPC) Program. This prestigious program positions Virginia at the forefront of nationwide community safety initiatives by instituting and maintaining rigorous standards for crime prevention within Warren County. On the 1st of June 2023, a significant milestone was achieved as the Warren County Sheriff's Office (WCSO) obtained accreditation from the esteemed Virginia Law Enforcement Professionals Standards Commission (VLEPSC). The acquisition of accreditation had been a paramount objective for Sheriff Butler since assuming his role, and it became a collaborative endeavor for the entire department. The diligent efforts of the WCSO's personnel over a span of three years culminated in this noteworthy accomplishment. In pursuit of accreditation, the WCSO welcomed an evaluation team that meticulously scrutinized all policies, procedures, and daily operational mechanisms of the office. The final.





### INCIDENT REPORTS OF PERSON CRIMES BY PRIMARY OFFENSE 2021-2023



## Court Services Division

Court Services comprises of Court Security, Court Holding, and Civil Process all operating collectively to offer exceptional services to the courts of Warren County.

Civil Process includes two full-time deputies. These servers offer extensive knowledge of all matters concerning the Civil Process. They are responsible for serving papers in both Front Royal and Warren County. They also serve papers for other agencies when the person to be served lives within Warren County. Some of the various papers the deputies serve are Jury Summons, Witness Subpoenas, Court Summons, Garnishments, and Writ of Possessions. These deputies work closely with landlords and their tenants to ensure the eviction process is completed per Virginia Code and great care is taken to educate and assist all parties involved. When not serving papers, these deputies will assist other divisions as needed.

The Court Holding facility utilizes the old Warren County Jail and is used to house prisoners who are transported from other jails for a court appearance. Court Hold is operated by highly trained, experienced deputies who specialize in the handling and security of prisoners and their transportation. These deputies complete many transports for prisoners who are not housed at RSW Regional Jail but have court appearances in Warren County courts. Court hold deputies also complete all extraditions for Warren County. This year deputies have flown or driven to many states including Massachusetts, New Mexico, Florida, Ohio, Texas, and Illinois to return fugitives back to the County for court hearings. Some other duties handled by the Court Hold staff are fingerprinting both court ordered and application prints, as well as obtaining DNA samples when ordered by the court.

Court Security's main function is to provide all courthouse staff and visitors with a safe and secure environment. Court Security consists of Bailiffs who provide security in the courtroom and checkpoint deputies who conduct thorough screenings of all visitors who enter the courthouse. These dedicated proficient deputies conduct regular searches of the courthouse and grounds. They also serve many civil court papers to parties involved in hearings, complete court ordered drug screens, and assist all visitors with their questions or concerns. The deputies have built great relationships with the staff and public they interact with in their day-to-day duties.

Also, in 2023 Warren County's Drug Treatment Court began. This program started with three participants and has quickly grown to six and is expected to soon expand to fourteen. This rehabilitation program works closely between the Sheriff's Office, Northwestern Community Services, Valley Health, Warren County Probation and Parole, Warren County Circuit Court, and the Front Royal Police Department. The deputy's role involves building relationships with participants and providing positive reinforcement and support for successful completion and a road to recovery.

## Patrol

The Patrol Division protects and serves the citizens of Warren County 24 hours a day, 365 days a year. The Patrol Division has four squads that work 12-hour shifts. These squads handle incoming calls for service and proactively patrol the community. The Patrol Division also has Animal Control, K-9 Unit, and the School Resource Officer (SRO) sections that supplement additional specialized staffing needs. The Patrol Division is overseen by one Captain, two Lieutenants, and supported by five shift Sergeants.

The Patrol Division consists of four squads that work 12-hour shifts, each is supervised by a Sergeant, who in turn reports to the Lieutenant of patrol and the Captain of patrol. In the year 2023 the WCSO Patrol Division responded to more than 18,979 calls for service (numbers from January 1<sup>st</sup>, 2023 – December 15<sup>th</sup>, 2023). These calls covered a vast variety of services which include but are not limited to:

- Assisting citizens that are in crisis,
- DUI/DUID enforcement through checkpoints and directed patrols,
- Enforcing traffic laws to encourage highway safety,
- Investigating traffic crashes,
- Assisting those in need of mental health services, and
- Responding to suspicious incidents and accidents.

This year the Warren County Sheriff's Office (WCSO) had many graduates from the Skyline Regional Criminal Justice Academy Law Enforcement Basic Classes. With this past class two of WCSO new deputies won awards. Deputy T. Romer won the award for Top Overall Achievement and Deputy B. Jost won The Ricky L. Timbrook Top Performance Achievement Award. We are very proud of all of our new graduates and would like to extend a sincere congratulations to these fine Deputies.

## Animal Control Services

Animal Control Officers (ACO) are responsible for animal related calls within Warren County as well as the Town of Front Royal. ACOs are certified law enforcement officers who have completed an additional three-week, specialized animal control training. The Animal Control Unit is overseen by the Patrol Division Sergeant and Lieutenants.

Of the 18,979 calls the Patrol Division responded to during 2023, there were 2,185 that the WCSO Animal Control Unit (ACO) were called for. This number does not include any calls that the ACO unit was asked to assist on. The Animal Control Officers are responsible for complaints involving

- Animal cruelty, neglect, and abuse.
- Stray or at large animals.
- License violations.
- Animal bites and rabies exposures.
- Injured animals and animal rescue operations.
- Wildlife complaints.
- Educating animal owners, providing resources to help resolve issues of neglect or possible financial circumstances preventing adequate care.
- Patrolling county areas to identify animal nuisance and noise violations.
- Investigating reports of animal abuse, filing charges as appropriate, preparing cases for prosecution, and providing court testimony.
- Responding to calls regarding stray, vicious and/or diseased animals; responds to calls regarding animal bites and perform preliminary investigations.
- Captures and transports stray, sick, injured or potentially rabid animals to appropriate animal shelter for processing, care and treatment and quarantines, as necessary.

Animal Control Officers supplement patrol deputies when the volume of calls for service is high or critical incidents arise.

## Sheriff's Office Canine (K-9) Program

The Sheriff's Office has a total of 5 canines. We are happy to introduce our two bloodhounds (K9 Ash and K9 Rooster), and three patrol canines (K9 Ace, K9 Gator, and K9 Roman). Some dogs are trained to detect narcotics, article searches, human scent detection, and criminal apprehension. Our K9 handlers are required to train a minimum of 16 hours a month totaling nearly 791 training hours this years.

Along with the 16 hours a month, our K9 Teams continue to train daily. You may notice them on foot patrols, or training at schools or other critical infrastructure before sporting events, prior to parades or other scheduled activities. This ongoing training helps keep the K9 handler and their K9 partners in a constant state of readiness, highly trained for whatever situation may arise.

In the year 2023 our narcotics K-9 Teams have been deployed 498 times being able to take a large assortment of dangerous drugs and narcotics off the county streets, approximately totaling 4,111.10 grams of narcotics with an approximate street value of \$134,016.50. In addition, our K-9 Teams also seized \$19,408.00 in United States Currency and a value of \$1,000 in firearms. Narcotics canine teams conducted approximately 89 vehicle K-9 sniffs along with 67 assists to other law enforcement agencies during the year.

Our bloodhound K9 Teams conducted 36 human scent tracks throughout Warren County, assisting with locating missing and endangered persons.

This is a competition that highlights the work of the both the handlers and their K-9 Partners with 33 teams participating this year. Sgt. Gregory and K-9 Partner Roman took 3<sup>rd</sup> in Narcotics Detection Vehicle Sniff, 3<sup>rd</sup> in agility, as well as 3<sup>rd</sup> in the gunfire station. It is with great pride we say this. Our Handlers and their partners work very hard throughout the year and it is thanks to competitions like these, that they can showcase their hard work and the special skills they have trained so hard for.







## School Resource Officers and Youth Programs

The School Resource Officer (SRO) Program is a community policing-based approach practiced within the school environment. School Resource Officers share their expertise through presentations in the classroom to promote and educate a better understanding of laws and the legal system. They provide guidance to parents, teachers, faculty, students, and serve as a link to services both inside and outside the school. SROs promote safety and security in the county's ten public schools and make themselves available to assist faculty and students. School Resource Officers also aim to create positive relationships with area youth through constructive interactions. The SRO Unit is overseen by one Sergeant and the Community Policing Units Lieutenant.

The School Resource Officer Unit is also involved in functions outside of the regular school day which include:

- Patrolling school sporting events, dances, and other functions
- Ten-week Drug Abuse Resistance Education (D.A.R.E.) course
- *D.A.R.E. Day* and the *Sheriff's Office Fun Day*
- Child Safety Seat Technicians; install and host installation events for citizens
- Read to children at the library monthly
- *Shop with a Sheriff* program for children in need
- *Hometown Halloween* event
- Deliver holiday meals to families in need and elderly
- Project Lifesaver team
- When school is out of session, SROs are assigned to other divisions as needed. They can also be used to supplement patrol when the volume of calls for service is high or critical incidents arise.



# Investigations

The Criminal Investigations Division (CID) is responsible for investigating major crimes, specializing in crimes against persons/children, property crimes, fire investigations, violent crimes, homicides, serious misdemeanor crimes and any other offenses as needed. Criminal Investigations Division (CID) provides and is provided investigative assistance and guidance to/from other divisions within the office as well as surrounding agencies. The Criminal Investigations Division is also a member of the **NOVA/DC ICAC Taskforce** (Internet Crimes Against Children).

Investigations works with every area of expertise when needed, which includes Patrol, School Resource Officers, Fire Marshal's Office and Department of Social Services, among others.

The Criminal Investigations Division is staffed by a Lieutenant, two investigators, two part -time evidence technicians, and a part-time crime analyst.

CID investigators are trained in advanced fields such as ChildFirst Forensic Interviewing, Cellebrite digital forensics, crisis negotiation, death investigation, fire investigation, photography, and sexual assault offenses.

In addition to investigative duties, investigators participated in Sexual Assault Response Team (SART) meetings, ICAC Task Force meeting, provided Revive! Rescuer Training to Warren County High School students and new deputies and conducted mock interviews with Criminal Justice students at Blue Ridge Technical Center.

- Two evidence technicians are responsible for maintaining the security, storage, disposal, and return of all evidence in accordance with Warren County Sheriff's Office Policy and all state and federal laws. The Warren County Sheriff's Office currently stores over 4,000 pieces of evidence, lost/found property, and property held for safekeeping. Over 1,000 pieces of evidence/property have been destroyed, released, or returned in 2023.

## Special Investigations Unit (SIU)

The Special Investigations Unit (SIU) proactively investigates vice, drugs, organized crime, and complaints of a complex nature that require a specialized investigative approach. The S.I.U. is comprised of one investigator and a part-time analyst under the purview of the Investigations Lieutenant. The SIU unit's duties include but are not limited to:

- Narcotics Interdiction
- Fugitive Apprehension
- Covert Vice/Narcotics Operations
- Surveillance Operations
- Gang Identification/Interdiction


The SIU works closely with other local law enforcement, federal, and Department of Corrections agencies.

### 2023 SIU Highlights

- Continued participation in the United States Postal Inspection Service Contraband Interdiction and Investigation Task Force (CI2)
- Assigned one investigator as a narcotics task force officer to the Department of Homeland Security
- Over \$20,000 U.S. currency seized from illegal narcotics operations.
- Over 80 pounds of illegal contraband seized In S.I.U. related investigations.



## Community Policing Unit (CPU)

The main purpose of the council is to facilitate open, honest, and direct interactions between the residents of Warren County and their Sheriff's Office. More specifically, the Community Advisory Council (CAC) aims to educate the community about services provided by the Warren County Sheriff's Office and engage our neighbors in community-oriented policing programs.

The Community Advisory Council (CAC) also educates the Sheriff's Office about needs within the community. The Community Advisory Council (CAC) may also provide feedback to the Sheriff's Office regarding planned law enforcement priorities and programs.


- Became an official Army PaYS Partner and hosted a signing ceremony.

## Administrative Services Division

The Administrative Services Division staff are responsible for supporting all Sheriff's Office Personnel as well as serving the public. They organize, record and maintain all documentation that comes through the Sheriff's Office including all civil papers, personnel records, patrol documents, investigations files, etc.

In 2023 the Administrative Services Division managed to complete cross training for all Administrative Services Division Positions. This has proven to be a great help when someone has an overflow of work or is out of the office. Our Administrative Division was more than happy to complete this training on top of their usual training such as VCIN, FOIA, RMS, Etc.

The Warren County Sheriff's Office (WCSO) Administrative Services Division played a huge part in our Accreditation process. With their help and contribution, the WCSO was able to locate many materials needed as well as completing many of that tasks that needed to be done to complete the process of receiving this great honor. It is thanks to the many people of our Administrative staff for making this possible through their hard work and dedication to constantly bettering this office and helping to make our community better.

In addition to all the amazing work this division manages to do on a day-to-day basis to keep our office running smoothly, our Administrative staff also played a key part in becoming a part of the Army's PaYS program. This is a great program that provides many opportunities to Veterans throughout this Country. Sheriff Butler made it a goal during his first campaign to increase involvement with the Veterans of Warren County, this is something he has managed to do every day since taking office, the Army PaYS program helps to further this vision for the WCSO.

Another crucial aspect that the Administrative Services Division helps with is grant work. The Administrative Services manager deals with a lot of the work that has to be done for grants and this plays quite the crucial part when it comes time to apply for grants and do maintenance to maintain grants. Grants help the WCSO to have additional money added to our budget for things such as training, supplies needed, and even overtime pay for our deputies.

Each section of our Administrative Services Division plays a large and important part in the daily things needed of this office but one that should not be forgotten is our Civil Process administrative personnel. They handle all civil and criminal papers as well as Freedom of Information Act (FOIA) requests. In 2022 the Records Administrator D. Orye handled 564 FOIA requests, which increased to 713 FOIA requests in 2023 (numbers are from January 1<sup>st</sup>, 2022 – December 15<sup>th</sup>, 2023). Mrs. Orye has further participated in interviewing, accreditation training, and has completed multiple courses such as FOIA Webinar, attended demonstrations for software, Eliminating Risk & Liability in Records, and many more.

## Administrative Services Division (continued)

The Administrative staff plays a key part in ensuring that the deputies training is tracked and that they are registered/signed up for any approved training, as well as making sure they have everything they need such as hotel, per diem, etc. This also includes when they have a certification that is about to expire and need to retake the training or reapply.

Along with making sure that all sworn personnel receive their needed training, the WCSO Administrative Staff are all trained in many different things that they use daily to better the department and workflow. Assistant Administrators also complete individualized training that includes but is not limited to: TRACER, VCIN, Lawful Employment training, IBR Level 1 and 2, and many more.

The Administrative Services Division also assists with the public events that are conducted by the Warren County Sheriff's Office. The WCSO Administrative Services has participated in many events such as the annual Christmas Parade, Fun Days, Meals on Wheels, National Night Out, Trunk or Treat, and many other events.

In addition to all of this, the Administrative staff has also taken care of scanning and storing all the Warren County Sheriff's Office Training documents, Certificates, Personnel Records, and any such documents to ensure proper records retention and retrieval. Both hardcopies and electronic copies of all the documents are maintained to ensure we always have them.

All the Administrative Division Assistants work closely with their respective Division Administrators as a team to ensure mission success.

## 911 Emergency Communications Center

The 911 Emergency Communications Center is a critical component of the Warren County Sheriff's Office (WCSO) as well as the Warren County Fire and Rescue. The Communications Center is responsible for all Radio Communications with sworn personnel as well as calls from the non-emergency line, and the 911 emergency line. All Communications Officers have completed on the job training and are working towards becoming DCJS certified. Other training required includes but is not limited to; Virginia Criminal Information Network (VCIN), FEMA, Emergency Medical Dispatch, Telephone CPR and many others.

Not only does the Communications Center handle all calls into the WCSO, but they also offer services such as but not limited to Language Translation, Text-to-911, Operation Telephone, and Rapid S.O.S. This year the 911 Emergency Communications Center was able to transition over to the EsiNet System. This system helps to provide better data of callers to C.O.'s such as video capabilities, pictures, text-to-911, and Geo-location.

The Communications Officers are there for you in some of the most intense moments of one's life and help to deescalate and find solutions to difficult situations.




## Professional Standards

Pursuing a standard of excellence and professionalism through the Virginia Law Enforcement Professional Standards Commission (VLEPSC) continued to be a major priority within the Sheriff's Office in the year 2023. The process for VLEPSC accreditation began in 2020 and completion was achieved on February 7, 2023. An important aspect of this program is the assurance that the Sheriff's Office consistently, fairly and effectively conducts administrative reviews and investigations to ensure compliance with its policies, practices and the state code.

The Sheriff's Office continued its journey in 2023 by adopting the new Policy Manual that conformed with the VLEPSC standards, which is maintained using the online tool called PowerDMS. This tool greatly increased the accountability of personnel for reviewing, understanding and complying with these policies and standards. The Policies are reviewed and updated annually.

The Warren County Sheriff's Office continues its transparent process of tracking citizen complaints, as well as internal administrative actions to ensure that the highest professional standards are sustained. The chart below reflects this Internal Affairs and Investigations outcomes for the year 2023.
